#### Rights as Data Subject under Article 11 of the PDPL

The rights of real persons whose personal data are processed, pursuant to Article 11 of the PDPL, are as follows:

- To learn whether personal data is processed or not,
- To request information if personal data has been processed,
- To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom personal data is transferred domestically or abroad,
- To request the correction of personal data in case of incomplete or incorrect processing and to request the notification of the correction to the third parties to whom the personal data has been transferred,
- To request the deletion or destruction of personal data, despite being processed in accordance with the provisions of the PDPL and other relevant laws, in the event that the reasons requiring processing are no longer valid, and to request the notification of the deletion or destruction to the third parties to whom the personal data has been transferred,
- To object to the occurrence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- To request the compensation of the damage in case of damage due to the unlawful processing of personal data.
